Here 3 days - I was targeted at a young age for a crime I did not commit. I was arrested, taken to a police station, held overnight in custody, and then brought to court on the Monday morning. From the very beginning, I felt powerless, frightened, and completely alone. I was just a young person, and I did not understand why this was happening to me.

After appearing in court, I was remanded to HMP Barlinnie, a male prison. I spent three nights there, and those three nights changed my life forever.

From the first night, I was subjected to horrific physical abuse. Prison officers — grown men with full authority and power over me — pushed me around, laughed at me, and assaulted me. I was beaten so badly that by the end of the first night my body was black and blue with bruises. I was treated as if I was less than human. Instead of protecting me, the officers allowed other inmates to bully me and physically attack me. They even let prisoners into my holding cell to beat me. I was trapped, defenceless, and terrified.

The worst part of my time in Barlinnie was being forced to share a cell with an older inmate who was a serious offender. For two nights, I was sexually assaulted by this man. I had no protection, no safety, and no one to turn to. I was a young person locked in a cell with someone who took advantage of me in the most degrading and traumatic way. The other prisoners were aware of what was happening. Instead of helping me, they mocked me, pushed me around, slapped me, and called me names. I was humiliated, degraded, and completely broken. My life in those three days was hell. I was mentally, physically, and sexually abused.

Here a week - , I was transferred to Longriggend Young Offenders Institution in Airdrie. By this point, I was already traumatised. My body was covered in bruises from the beatings I had endured. I was in constant fear.

At Longriggend, I was locked in a cell for 23 hours a day. I had to eat in my cell, isolated and alone. The small amount of time we were allowed out of our cells was filled with fear. I had to brace myself every single time, expecting another violent attack. There were fights everywhere. The environment was aggressive, chaotic, and frightening. Many of the others were older than me, and I felt completely vulnerable.

The conditions were freezing and uncomfortable. The sleeping arrangements were inadequate, and I struggled to rest. I was already physically injured, and the cold only made it worse. The food was extremely poor, and I often went hungry because I could not stomach it. I felt mistreated, neglected, and abandoned by a system that was supposed to protect people in custody.

After a week at Longriggend, I was taken back to court. The charges against me were proven not guilty, and I was finally allowed to return home to my family. However, by that point, the damage had already been done.

Although I was found not guilty, I had already endured severe mental, physical, and sexual abuse. The trauma did not end when I was released. It has followed me every day since.

I suffer from ongoing nightmares about what happened to me. I relive the assaults and the fear. I have been diagnosed with, and continue to struggle with, PTSD, anxiety, and depression as a direct result of what I experienced. I feel constantly on edge, easily startled, and unsafe. I struggle with trust, especially around authority figures. I experience flashbacks, panic attacks, and overwhelming feelings of fear and helplessness.

At the time, my mental health deteriorated almost immediately. I felt ashamed, confused, and broken. I did not know how to process the sexual assault or the violence. I felt that I had been treated as worthless. Now, years later, I still carry that trauma. It has affected my relationships, my confidence, my ability to sleep, and my overall quality of life.

I was a young, innocent person who should have been protected. Instead, I was abused in every possible way. I was failed by the system that was meant to keep me safe. I was found not guilty, yet I paid the price physically, emotionally, and psychologically.

My life has never been the same since those days in custody. The abuse I suffered has left permanent scars — not just on my body at the time, but on my mind and my mental health, both then and now.
